2. The Farmers Market season is from May to October, approximately 26 weeks.
3. **Title Sponsor:** If the Title Sponsor chooses to set up booth space at the Market, the Title Sponsor is required to be in compliance with current rules and regulations of the Virginia Health Department (VDH) and Virginia Department of Agriculture and Consumer Services (VDACS). Market dates must be confirmed with the Market Manager at least two weeks in advance.
4. The Town of Damascus has the exclusive right to review and either accept or reject any and/or all sponsorship applications.
5. **Liability:** The Town of Damascus, Virginia and the Damascus Farmers Market assume NO liability for damage, theft, personal injury, or weather conditions, or otherwise.
